**APPLICATIONS** may be filed in person, by mail, or by an agent provided the designated form is properly completed and signed by the Applicant. No e-mails or faxes will be accepted. The document must be an original.

**REVISIONS OF THE LIST** shall be undertaken at the Township Office, from 8:30 a.m. to 4:30 p.m., Monday to Friday, commencing Tuesday, September 7, 2010 through to Monday, October 25, 2010; or by mail by the applicant.

**VOTER IDENTIFICATION (original documents)** showing the person's name, qualifying address, and signature must be presented.

**Municipal Elections in the Township of Malahide for the offices of:**

**Council:**

Mayor - 1 to be elected at large  
Deputy Mayor - 1 to be elected at large  
Councillor – 1 to be elected in each of Wards 1, 2, 3, 4, and 5

**School Boards:**

Trustee - Thames Valley District School Board – 2 to be elected for the County of Elgin

Trustee - London District Catholic School Board - 1 to be elected for the County of Elgin

Member - Conseil de district du Centre Sud-Ouest (French Language Public District School Board) - 1 to be elected for the entire geographic area of the the Counties of Elgin, Haldimand-Norfolk, Oxford, Lambton and the Municipality of Chatham-Kent

Member - Conseil scolaire de district des écoles catholiques de Sud-Ouest (French Language Separate District School Board) - 1 to be elected for the entire geographic area of the County of Elgin, the County of Middlesex, and the City of London

**will be held on the 25<sup>th</sup> day of October, 2010.**

The Township of Malahide will be utilizing an alternative method of voting - **VOTE BY MAIL** - for the 2010 Municipal Elections. Should voters be unable, or choose not to mail their vote, a ballot return station at the Municipal Office will protect their right to vote by allowing them to deliver their ballots in person right up to the Close of Voting on Voting Day.
